- The Office for Sustainability (OS), a unit belonging to the Delegation of the Rector for Social and Corporate Responsibility Policies, was created at the beginning of the 2004-2005 academic year.
- Objective: that our university advances towards sustainability, following a model of social responsibility whose purpose is to respond to the expectations of the university community.
- Functions: Since its creation, its functions and activities have grown, quantitatively and qualitatively, developing consolidated programs of awareness, promotion, prevention, dissemination, information, attention to needs, technical advice, training, research, publication, intervention, provision of services, etc.
- It takes as a general framework of action the Declaration of Environmental Policy of the University of Cádiz, endorsed by an agreement of the Governing Council of July 20, 2006.
- It focuses its actions on the Sustainability Promotion Plan.

What do we do?

Taking the social responsibility of the UCA with respect to the environment and in the attempt to achieve a fully sustainable university model, the lines of action in which we work in the Office for Sustainability are the following:

- Education, training and environmental awareness.
- Participation and promotion of Environmental Volunteering.
- Environmental Information and Communication.

These lines of action are based on the principle of the United Nations Assembly (2002), endorsed by CRUE Spanish Universities (2005):

"The university community, in accordance with its commitment to sustainability in the pursuit of environmental quality, social justice and a viable and equitable economy, considers that the generation of a culture that contributes to an integral human development and environmentally sustainable "

The Sustainability Promotion Plan organically integrates all the components of sustainability (economic, social and environmental) in the substantive functions of the university to strengthen the performance of its academic programs and its social projection, based on a broad and committed participation of the university community as a whole.

Said plan is made up of a set of actions framed within several thematic areas of action that work in an interrelated and complementary manner with each other, in such a way that they drive and promote actions that materialize the environmental commitment of our university.

Thus, the lines of action on which it is working range from energy efficiency, sustainable mobility, through better use of water or the management of waste generated in all

university areas.

SUSTAINABLE MOBILITY

The University of Cádiz, within the framework of the obligations that is imposed framed within the scope of its commitment to Social Responsibility, understands as one of the guidelines of this, the promotion of policies related to Sustainable Mobility, being essential the promotion of actions that facilitate information on good practices regarding Sustainable Mobility and that promote the daily use of means of transport that respect the environment, as well as collaborative formulas around private transport (efficient driving strategies, shared vehicles, stations electric vehicle recharging, etc.).

UNITED NATIONS 2030 AGENDA

The University of Cádiz is aligning its sustainability strategy with the 2030 Agenda for Sustainable Development, adopting a firm commitment to the Sustainable Development Goals (SDG) as part of the new Transversal Strategy for Social Responsibility (2021-2025).

The strategy of the University of Cádiz covers the 17 Goals, interrelated to cover the three dimensions of sustainable development: economic growth, social inclusion and environmental protection, from the perspective of its functions as a public Higher Education Institution. : teaching, research, transfer, commitment to the socioeconomic development of our territory, providing us with organizational structures of recognized excellence in the national and international spheres.

As the University of Cádiz has been demonstrating with its commitment to the 2030 Agenda and therefore to climate change, we continue to advance as dynamic agents of change, being aware of the decisive role that we play in the achievement of SDG13 "Climate Action" by confronting the collective construction of a Climate Action Plan, through the participatory project "Declaring ourselves in Climate Emergency".

It will be a driving force, headed by the Office for Sustainability with the participation of the university community, student organizations for the climate and in collaboration with civil organizations such as Fridays for Future, Extinction Rebellion and Ecologistas en Acción Andalucía, responsible for promoting a process of participation and collective creation based on participatory action research (PAR) leading to the development of said plan.
