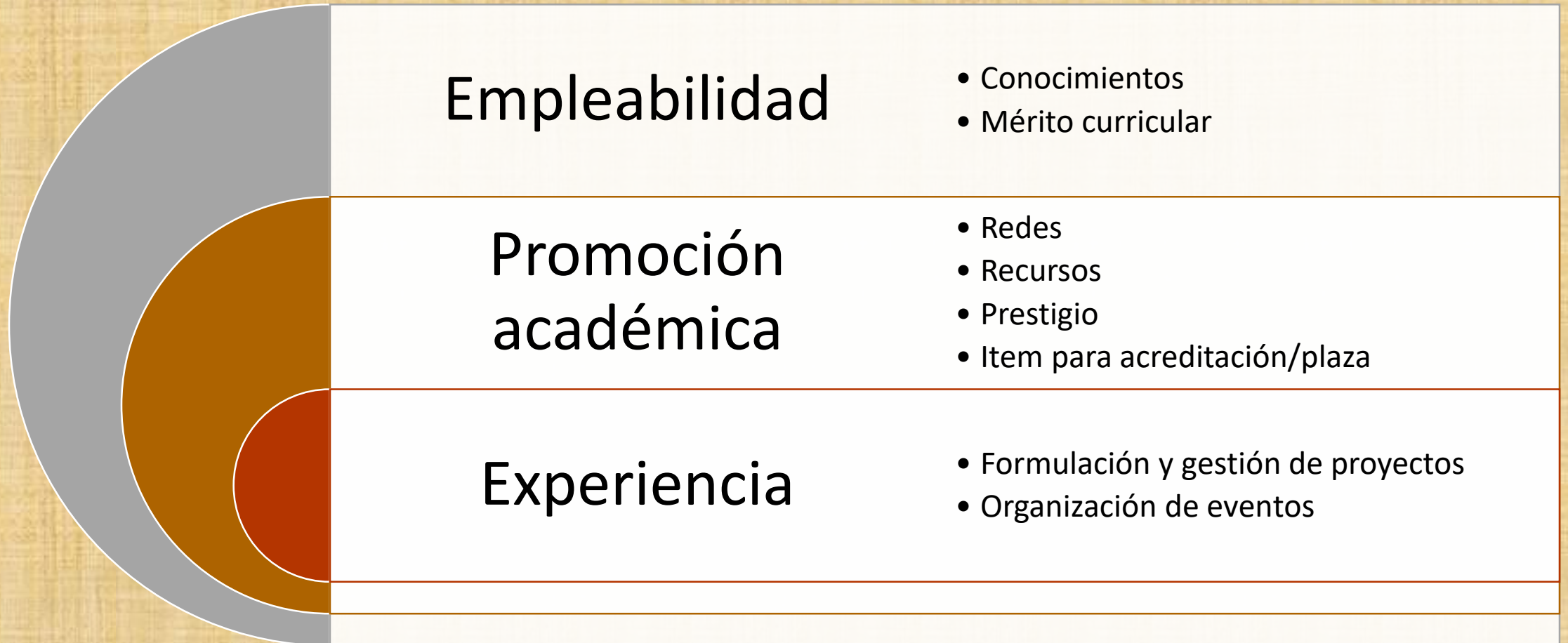

Tipos de acciones Jean Monnet

1. Actividades de educación e investigación

Módulo Jean Monnet

- Short teaching programme in the field of European Union Studies at a higher education institute.
- Each Module lasts 3 years with a minimum duration of 40 teaching hours per academic year.
- Modules may concentrate on one particular discipline in European studies or be multidisciplinary in approach
- Max. 30.000€

Cátedra Jean Monnet

- is a teaching post with a specialisation in European Union Studies for university professors for duration of 3 years.
- The position must be held by only one professor, who must not only teach a minimum of 90 teaching hours per academic year (for 3 consecutive years) but also carry out at least one additional activity per academic year as described in the Programme Guide
- Max. 50.000€

Centro de excelencia

- a focal point of competence and knowledge on European Union subjects with project duration of 3 years.
- The Centre has a major role in reaching out to students from faculties not normally dealing with European Union issues as well as to policy makers, civil servants, organised civil society and the general public.
- The requirement to hold a Chair in order to set up a Centre of Excellence is removed.
- Max. 100.000€

Ejemplo de Cátedra Jean Monnet

European Integration Journalism

Duración: 2016 – 2019

Participantes: Students from the School of Journalism and Mass Communications at different levels, students from Faculty of Economic and Political Sciences, wider audience of journalists

Universidad: ARISTOTELIO PANEPISTIMIO THESSALONIKIS, Greece

The Jean Monnet Chair on European Integration Journalism, intends to change the way European politics and challenges are reported by media outlets and journalists; explore new opportunities and challenges of journalism practices and coverage on the European Union, its institutions and policies

Objetivo: increasing the effectiveness and strengthen the professionalism of journalists and students to improve their ability to understand and report on the EU.

Resultados: Teaching activities, workshops, quality research (publication of a book, articles in peer-reviewed journals as well as a number of conference papers).

2. Apoyo a asociaciones

- Jean Monnet activities offer support to associations that have as their explicit purpose to contribute to the study of the European integration process. Such associations should be interdisciplinary and open to all interested professors, teachers and researchers specialising in European Union issues in the relevant country or region.
- They should be representatives of the academic community in European Union studies at regional, national or supranational level. (3-years project)
- Max. 50.000€

3. Debate sobre políticas con el mundo académico

Redes Jean Monnet

- to foster the creation and development of **consortia** of international players (HEIs, Centres of Excellence, departments, teams, individual experts, etc.) in the area of European Union studies.
- Networks gather information, exchange practices, build knowledge and promote the European integration process around the world. This Action can also support the enhancement of existing networks supporting specific activities, notably fostering the participation of young researchers in EU-related themes.
- These projects are based on unilateral proposals, focused on activities that cannot be achieved successfully at a national level and require the involvement of a minimum of 3 partner institutions from 3 different countries.
- Max. 300.000€

Proyectos Jean Monnet

- are granted for 1 to 2 years to support innovation (e.g. projects on Learning EU at School), cross-fertilisation and the spread of European Union content.
- These projects are based on unilateral proposals – although the proposed activities may involve other partners.
- Max. 60.000€

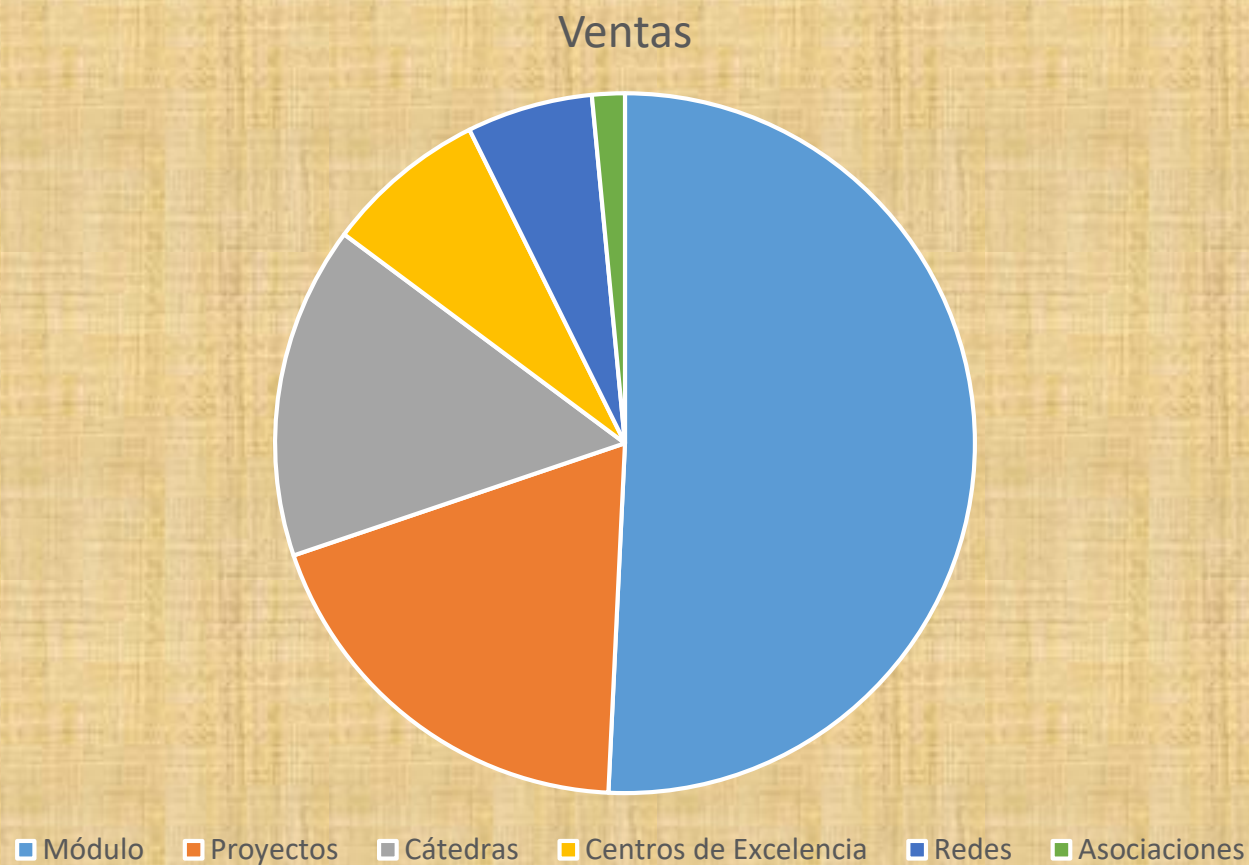

- 1255 propuestas
- 747 (60%) de non-EU countries, which shows a high international interest.
- 235 projects were funded in total, 115 for activities in non-EU countries.
- The success rate for these actions remains low at 19%.

The CiviPol Jean Monet Module will contribute to the specific objective of fostering the publication and dissemination of the results of academic research in several manners. First, the courses taught will contribute to disseminate the knowledge and results produced in the past and ongoing research projects of the key staff members and invited lecturers (see sections E3 and H for details about the academic production of the applicants). The academic production of the staff is mainly related to the following topics:

- third sector
- trade unions and social and economic policy
- migration policies and migrants' social participation
- urban planning and social movements
- social policy
- social and political movements

Second, the 3 International Workshops will also contribute to disseminate the results of the research activities of the staff, expanding the audience to other scholars of other countries. Third, the proposal includes a set of Open Access publications and products that will permit to reach a wider audience: social media, press notices, website, one article in an academic journal, and a Massive Open Online Course (MOOC).

- With regards to the second specific objective addressed in this proposal, creating interest in the EU and constituting the basis for future poles of European knowledge, particularly in Partner Countries, the CiviPol project expects to reinforce the EU dimension of the research conducted by academics of the University of Cádiz and their expanded academic networks. In this sense, preparing teaching material for the course will drive academics to acquire a deeper knowledge on the European dimension of their research lines and to develop a cross-national EU vision of the studied problems. In addition, this Module expects to be the point of departure of further research proposals at the EU level. By the end of the project the researchers expect to apply for a Marie Curie-RISE project in order to give continuity to the networks and collaborations favoured by the Jean Monnet Module.
- The third specific objective of the Action that will be addressed by in this proposal is fostering the introduction of a European Union angle into mainly non EU related studies. It has been said that the EU dimension of the topics taught and researched by the applicants at the University of Cádiz is underrepresented. Working in this Module will contribute to introduce an EU angle on such themes. The teaching and research activities of the applicants are expected to be reinforced by the introduction of this EU angle, for example, by studying how EU institutions and regulations affect studied phenomena at other scales, or by examining such social problems at an EU cross-national comparative perspective.
