## TEACHING METHODOLOGY

#### **TEACHING METHODOLOGY**

Material that each subject must have:

Theoretical material: ppt with integrated audio or video presentation, basic bibliography and complementary theoretical material.

Duration of asynchronous classes (video recording): between 60 and 90 minutes maximum.

Duration of power point presentations with audio included: 60 minutes maximum.

Duration of synchronous classes: between 60 and 90 minutes maximum. Google meet or Big Blue Button (the latter tool is available on the virtual campus)
